THE COMMUNITY FOOD MARKET DISTRIBUTED FOOD TO 3,299 HOUSEHOLDS COMPRISING 9,263 INDIVIDUALS. THIS PROGRAM PROVIDED 19,451 DAILY FOOD MARKET VISITS AND 11,396 MONTHLY FOOD MARKET VISITS. THE HAVEN DISTRIBUTED 2,105 TONS OF FOOD. FORTY-EIGHT PERCENT OF ALL HOUSEHOLDS VISITED THE COMMUNITY FOOD MARKET AT LEAST TWICE DURING THE YEAR WITH 28% SIX OR MORE VISITS. IN ADDITION, THE HAVEN ALSO DISTRIBUTED FOOD TO MULTIPLE COMMUNITY PARTNERS, INCLUDING SIX MEDICAL CLINICS AT DARTMOUTH-HEALTH AND ALICE PECK DAY HOSPITAL, THE MOMS IN RECOVERY PERINATAL CLINIC, AND SEVERAL SMALLER FOOD PANTRIES.

THE AVERAGE LENGTH OF STAY FOR EXITING HOUSEHOLDS WAS 191 DAYS. THE HIXON ADULT SHELTER SERVED 55 ADULTS AND PROVIDED 4,914 SHELTER BED NIGHTS.
